Walter E. York Memorial Scholarship Application

The Walter E. York Memorial Scholarship was established in 1999 by Encompass Credit Union in memory of their founder. Mr. York worked for Steel Parts manufacturing for 39 years where he started the credit union out of his desk drawer to help fellow employees with loans to meet their needs. York continued his leadership of the credit union from 1956 to 1988 in addition to his endless service to the community he loved.

The Walter E. York Memorial Scholarship is a non-renewable scholarship awarded annually to a graduating high school senior pursuing an education at an accredited institution of higher learning from Tipton High School, Tri-Central High School, Frankfort High School, Elwood High School, Clinton Central High School, Clinton Prairie High School, and Rossville High School. Seniors who are home schooled or attend one of the surrounding community schools may also be considered if they meet the qualifications. Determination of the scholarship winners will be based the applicants' financial need and merits.

You are responsible for seeing that all supporting documents are submitted. The Scholarship Committee and its affiliate organizations reserve the right to process only applications found to be complete as of the application deadline.
